



MEMORANDUM OF UNDERSTANDING

BETWEEN

NATIONAL POLYTECHNIC INSTITUTE OF CAMBODIA

AND

FSFEE HE "TAMBOV STATE TECHNICAL UNIVERSITY", RUSSIAN FEDERATION

ON

EDUCATION AND COMMON RESEARCH FIELDS

This Memorandum of Understanding is made on 19th February 2024 in Phnom Penh, the Kingdom of Cambodia, by and between:

1- The National Polytechnic Institute of Cambodia is located at Tomnup Kabpsrov Road, Prey Propel Village, Samraung Kraum Commune, Posenchey District, Phnom Penh, Kingdom of Cambodia (hereinafter referred to as "Party A");

2- FSFEE HE «Tambov State Technical University», 106/5, bld.2, Sovetskaya str., Tambov, Russia represented by Professor Mikhail Krasnyanskiy, Doctor of Technical Sciences, Rector Federation, acting on the basis of the Charter

hereinafter referred to individually as the "Party" and collectively as "Both Parties";

PREAMBLE

Establishing this Agreement to foster international cooperation in education and common research fields.

THEREOF Both Parties reached the following understanding:

ARTICLE 1

SCOPE

Both parties agree to encourage the following activities, in particular to promote international academic cooperation:

- 1.1. Exchanging students, scientists and academic staff to organize joint study and scientific programs including programs of additional professional training and internships within the frame of individual agreements;
- 1.2. Participation/organization of conferences, seminars and publication of scientific and methodical proceedings;
- 1.3. Reviewing scientific publication, thesis of dissertation, other research work;
- 1.4. Exchanging the information about seminars and scientific conferences organized by both parties;
- 1.5. Applying and participation in joint research projects;
- 1.6. Exchanging the information and documentation including methodical recommendations, scientific publications and research results.

ARTICLE 2

FUNDING

This Agreement is not considered to be a contract with legal and financial relationships. Rather, it is designed to facilitate and develop genuine and mutually beneficial exchange process/research relationship. To carry out concrete programs, the parties will arrange other agreements as supplements to the present one specifying financial and juridical responsibilities.

ARTICLE 3

TERMS

This Agreement is concluded for a period of 5 years and comes into force from the date of its signing by both parties. The term of this Agreement will be automatically extended for subsequent five-year periods, unless either Party notifies the other Party 6 months before the expiration of the next 5-year period of its intention to terminate it.

ARTICLE 3

CLOSING

This Agreement may be terminated with a minimum of 120 days written notice of any party.

Parties designate a person or office to serve as liaison in order to implement this Agreement.
