



COOPERATION AGREEMENT between

NATIONAL ADVANCED SCHOOL OF POSTS, TELECOMMUNICATIONS, INFORMATION AND COMMUNICATION TECHNOLOGIES (SUP'PTIC) CAMEROON

and

FSFEE HE "TAMBOV STATE TECHNICAL UNIVERSITY", RUSSIAN FEDERATION

The National Advanced School of Posts, Telecommunications, Information And Communication Technologies (SUP'PTIC), represented by his Director, Mr Watching Felix, acting on the basis of the Charter

and FSFEE HE «Tambov State Technical University», 106/5, bld.2, Sovetskaya str., Tambov, Russia represented by Professor Mikhail Krasnyanskiy, Doctor of Technical Sciences, Rector, acting on the basis of the Charter

Hereinafter jointly referred to as Parties, and individually – Party, establish this Agreement to foster international cooperation in education and common research fields.

- 1. Three parties agree to encourage the following activities, in particular to promote international academic cooperation:
 - 1.1. Exchanging students, scientists and academic staff to organize joint study and scientific programs including programs of additional professional training and internships within the frame of individual agreements;
 - 1.2. Participation/organization of conferences, seminars and publication of scientific and methodical proceedings;
 - 1.3. Reviewing scientific publication, thesis of dissertation, other research work;
 - 1.4. Exchanging the information about seminars and scientific conferences organized by bothparties;
 - 1.5. Applying and participation in joint research projects;
 - 1.6. Exchanging the information and documentation including methodical recommendations, scientific publications and research results.
 - 1.7. promote cultural exchanges between universities through the development of joint activities

- aimed to the blossoming and exchanges between their students
- 1.8. Co-organize joint study programs giving rise to co-diploma by all parties; the terms of codiploma agreed between the parties will be a subject of a specific agreement
- 2. This Agreement is not considered to be a contract with legal and financial relationships. Rather, it is designed to facilitate and develop genuine and mutually beneficial exchange process/research relationship. To carry out concrete programs, the parties will arrange other agreements as supplements to the present one specifying financial and juridical responsibilities.
- 3: This Agreement is concluded for a period of 5 years and comes into force from the date of its signing by both parties. The term of this Agreement will be automatically extended for subsequent five-year periods, unless either Party notifies the other Party 6 months before the expiration of the next 5-year period of its intention to terminate it.
- 4. This Agreement may be terminated with a minimum of 120 days written notice of any party.
- 5. Parties designate a person or office to serve as liaison in order to implement this Agreement.
