



MEMORANDUM OF UNDERSTANDING

between

Society "TAMBA-TAMBOV", JAPAN

and

FSFEE HE "TAMBOV STATE TECHNICAL UNIVERSITY",
RUSSIAN FEDERATION

The society „TAMBA-TAMBOV”, 1094-1, Asahi, Kasuga-cho, Tamba, Hyogo, Japan, represented by President Masato Kawazu

and FSFEE HE «Tambov State Technical University», 106, Sovetskaya str., Tambov, Russia represented by Professor Mikhail Krasnyanskiy, Doctor of Technical Sciences, Rector

Hereinafter jointly referred to as Parties, and individually – Party, establish this Memorandum to foster international cooperation in education, cultural and common research fields.

1. Both parties agree to encourage the following activities, in particular to promote international academic, cultural and scientific cooperation:
 - 1.1. Educational activity:
 - Exchange of experience, improvement of training quality in professional and additional education;
 - advanced training and retraining of university staff;
 - organization of internships within the frame of individual agreements.
 - 1.2. Research activity:
 - Organization of scientific seminars, symposiums, conferences and other joint activities;
 - Studying the experience of innovative educational institutions.
 - 1.3. Information activity:

- Information exchange;
- Joint PR actions, mass media communication;
- Exchange of information and other materials.

1.4. Social activity

- Development of partner relations with public organizations;
- Organization of exhibitions, social and volunteer events.

2. This Memorandum is not considered to be a contract with legal and financial relationships. Rather, it is designed to facilitate and develop genuine and mutually beneficial exchange process/research relationship. To carry out concrete programs, the parties will arrange other agreements as supplements to the present one specifying financial and juridical responsibilities.
3. This Memorandum becomes effective as of the date of signatures of both parties. The Memorandum may be amended by the written consent of the parties.
4. This Memorandum is valid for 5 years. It may be extended for additional periods upon the written consent of both parties.
5. This Memorandum may be terminated with a minimum of 120 days written notice of any party.
6. Parties designate a person or office to serve as liaison in order to implement this Agreement.
