



## COOPERATION AGREEMENT

between

**Al-Amarah University College**, address Al Amarah – Kut Highway, in front of College of Engineering of University of Misan, Misan, Iraq represented by Rector (Dean) Prof. Dr. Hameed Hasan Taher, acting on the basis of Charter.

and **FSFEE HE «Tambov State Technical University»**, 106/5, bld.2, Sovetskaya str, 392000, Tambov, Russia, represented by Professor Mikhail Nikolaevich Krasnyanskiy, Rector, acting on the basis of the Charter

Hereinafter jointly referred to as Parties, and individually – Party, establish this Agreement to foster international cooperation in education and common research fields.

1. Both parties agree to encourage the following activities, in particular to promote international academic cooperation:
  - 1.1. Exchanging students, scientists and academic staff to organize joint study and scientific programs including programs of additional professional training and internships within the frame of individual agreements;
  - 1.2. Participation/organization of conferences, seminars and publication of scientific and methodical proceedings;
  - 1.3. Reviewing scientific publication, thesis of dissertation, other research work;

1.4. Exchanging the information about seminars and scientific conferences organized by both parties;

1.5. Applying and participation in joint research projects;

1.6. Exchanging the information and documentation including methodical recommendations, scientific publications and research results.

2. This Agreement is not considered to be a contract with legal and financial relationships. Rather, it is designed to facilitate and develop genuine and mutually beneficial exchange process/research relationship. To carry out concrete programs, the parties will arrange other agreements as supplements to the present one specifying financial and juridical responsibilities.

3. This Agreement is concluded for a period of 5 years and comes into force from the date of its signing by both parties. The term of this Agreement will be automatically extended for subsequent five-year periods, unless either Party notifies the other Party 6 months before the expiration of the next 5-year period of its intention to terminate it.

4. This Agreement may be terminated with a minimum of 120 days written notice of any party.

6. Parties designate a person or office to serve as liaison in order to implement this Agreement.
