

AGREEMENT ON INTERNATIONAL COOPERATION

between

TAMBOV STATE TECHNICAL UNIVERSITY

Tambov, Russian Federation

and

UK COLLEGE OF ENGLISH

London, Great Britain

Tambov State Technical University represented by the Department of Foreign Languages and Professional Communication and UK College of English conclude an agreement on the development of international cooperation in the field of teaching and teaching English.

1. Both parties will organize and carry out the following activities in order to promote international academic cooperation:
 - a. Long-term and short-term English courses, including business English, preparation for international exams and individually designed courses aimed at improving students' skills in the field of English;
 - b. Educational trips providing students with a unique experience in intercultural communication;
 - c. International programs and projects to strengthen teamwork and collaborative learning and teaching;
 - d. Continuing education of teachers of English;
 - e. Other mutually agreed educational programs.
2. The parties will discuss the opportunities and challenges presented and may conclude specific agreements based on mutually agreed goals and results.
3. This agreement forms the basis for cooperation between the parties in order to determine and achieve common goals and objectives, as well as to promote mutually beneficial educational activities and the development of relations. This agreement is not binding and does not impose any legal or financial obligations (responsibilities) on both parties.
4. This agreement shall remain in force for five years from the date of signing if (i) one of the parties does not terminate it earlier, having notified the other party in writing, or if (ii) the joint activity stipulated by this agreement is completed before end of a five year period. The parties may extend the five-year cooperation agreement by mutual agreement.
5. The UK College of English will not use the name of TSTU, nor the name of any TSTU employee participating in the program, in any advertising or press release without prior written approval from an authorized representative of TSTU. TSTU will not use the name of the UK

College English, nor the name of any employee of the UK College of English, in any advertising or press release without prior written approval from an authorized representative of the UK College of English.

6. Each party must designate a person or department to act as the contact person for the implementation of this agreement. For TSTU, the contact person is Natalia Gunina, Russia, Tambov, ul. 7. If this agreement is executed in two languages, the English version of this agreement represents a complete understanding between the parties. Any other option is a translation. In the event of inconsistencies between the two options, the English version shall prevail.
