Hereinafter jointly referred to as Parties, and individually – Party, establish this Agreement to foster international cooperation in education and common research fields.

1. Both parties agree to encourage the following activities, in particular to promote international academic cooperation:
  - 1.1. Exchanging students, scientists and academic staff to organize joint study and scientific programs including programs of additional professional training and internships within the frame of individual agreements;
  - 1.2. Participation/organization of conferences, seminars and publication of scientific and methodical proceedings;
  - 1.3. Reviewing scientific publication, thesis of dissertation, other research work;
  - 1.4. Exchanging the information about seminars and scientific conferences organized by both parties;
  - 1.5. Applying and participation in joint research projects;

1.6. Exchanging the information and documentation, including exchange of methodical recommendations, scientific publications and research results.

2. This Agreement will be applicable to educational and research organizations attached to each party.
3. This Agreement is not considered to be a contract creating legal and financial relationships between the parties. Rather, it is designed to facilitate and develop a genuine and mutually beneficial exchange process/research relationship. To carry out concrete programs, the parties will conclude other agreements as supplements to the present Agreement specifying financial and official responsibilities.
4. This Agreement becomes effective as of the date of signatures of both parties. The Agreement may be amended by the written consent of the parties.
5. This Agreement is valid for 5 years. The Agreement may be extended for additional periods upon the written consent of both parties.
6. This Agreement may be terminated by either party with a minimum of 120 days written notice.
7. Each party designates a person or office to serve as liaison in order to implement this Agreement.


