



## Memorandum of Understanding

Between Al-Muthanna University and Tambov State Technical University

As a desire from Al-Muthanna University, represented by its president prof. Dr. Amir Ali Hussein Al-Atwi, which represents the first party and Tambov State Technical University, represented by its president prof. Dr. Mikhail Krasyanskiy, which represents the second party, to reinforce the cooperation in the cultural, scientific and academic fields, the two parties have agreed on the following:

**Article No. 1:** The content of the current Memorandum of Understanding embodies the aims and attentions that are expected from this agreement and all its articles are considered as one unit. The introduction is an integral part of this Memorandum.

Article No. 2: The two parties reinforce cooperation in any specialization or project presented by each of the parties as well as other cooperation fields in which the two parties feel that they could serve the mentioned aims above. These activities are subject to the consent of both parties and the availability of financial support.

Item No. 1: Exchange students, scholars and academic staff according to the scope of the Memorandum.

<u>Item No. 2:</u> Participate and organize scientific conferences and publish their scientific chronicles.

<u>Item No. 3:</u> Review the scientific publishes, theses, dissertations and other research work.

<u>Item No. 4:</u> Exchange information concerning workshops and scientific conferences organized by each party.

<u>Item No. 5:</u> Conduct and participate in joint research projects.

<u>Item No. 6:</u> Exchange information and documents including recommendations, scientific publishes, and research results and conclusions.

## Article No. 3:

<u>Item No. 1:</u> This Memorandum of Understanding is not a contract that includes financial and legal obligations. It is set to facilitate and develop exchanged academic relations that serve both parties and to carry out actual programs.

Item No. 2: The financial and administrative issues are to be agreed upon through a direct communication between the two parties. Their details are to be determined according to an executive agreement or an appendix attached to the body of the memorandum to be an integral part of it, having all the items of work in details including the costs, schedule as well as expected outputs of implementing the agreed items and to be signed by both parties and attached to the Memorandum of Understanding to be binding for both parties.

Article No. 4: It is not permissible to change, amend, reconsider, or add articles to this Memorandum only with the written consent of both parties and become an integral part of it and shall enter into force according to the procedures mentioned in Article No. 5.

## Article No. 5:

- A) This Memorandum comes into force from the date of the last notification for both parties that the legal procedures supporting their entry into force have been completed in accordance with the lows of both countries. The Memorandum stays in effect for (5 years) that could be renewed or extended, unless the parties decided to cancel it. Cancellation should be made by a written notification, six months prior to the expiry date of this Memorandum.
- B) This memorandum is not legally binding on both parties.

Article No. 6: If the Memorandum canceled or terminated, it will stay in force until the completion of the activities that have been already started.
